**Invitation of Bids for Building & Running KIOSK.**

Sealed Bids are invited on two bid basis (Technical + Financial) to **build and run** a healthy food **KIOSK** on license fee basis by the Principal, Kamala Nehru College (University of Delhi), August Kranti Marg, New Delhi-110049 from reputed and experienced outlets companies/firms/industries. The minimum License fee for Kiosk **Size 10'X10'** in the College for providing fresh fruits/salads/juices/healthy food/any other items as desired by the college, would be Rs. 15,000/p.m. (which is exclusive of electricity (as per usage), water & waste management. charges as decided by the college at the time of acceptance of the work). A refundable security amount of Rs. 50,000/- must be paid by the vendor. No interest will be payable on the security amount which will be refunded after 3 months from the date of expiry of the contract.

The contract will be awarded for an initial period of six months. It may be extended for a maximum period of five years, subject to satisfactory performance report by the competent authority, subject to annual review.

The license fee shall be subject to a minimum 10% revision on annual basis.

**Two Bid System** - The bidders are directed to provide list of healthy food items, which may include but not be limited to (a) fresh juices/fruits/ salads/dry fruits snacks/sprout chat etc., Experience details with supporting documents in running kiosk services/canteen services/cafes/cloud kitchen etc. to be submitted in the Technical Bid envelope. Financial bid should contain details for License fee exclusive of electricity, water, waste management, applicable charges/taxes etc. to be paid on the company letter head. **The finalized bidder will build the kiosk at own cost**, as per specification approved by the College.

The sealed quotation superscripted as "**BID TENDER FOR HEALTHY FOOD KIOSK**" must reach the College office in the name of the Principal, Kamala Nehru College, August Kranti Marg New Delhi 110049 latest by 09.02.2026 upto 05:00 p.m.

The College may invite shortlisted bidders from the technical bid for a presentation. Financial bids of the bidders qualifying in the presentation will only be considered. The bidders who fail to appear for presentation will not be considered for financial bid evaluation.

The design of the Kiosk will be approved by the competent authority of the college. Any changes thereafter will only be made after obtaining written approval from the competent authority of the college. The bidder will be allowed to take away/dismantle the Kiosk after the completion or termination of the contract.

**The College reserves the right to accept/cancel/reject the bid /cancel tender in partial form or in total without assigning any reason thereof.**
