#### 2. Additional Important requirements from Bidders:

- a) Must be a registered member of ICAI (Institute of Charted Accountants of India).
- b) Normally the composition of audit team should not be changed. However, under certain circumstances beyond control of the Audit firm, if the same need to be changed in any manner, it may be done after prior consultation with the Principal Kamala Nehru College. The audit team members should carry Photo ID issued by the Audit Firm.
- c) The initial tenure of engagement of Internal Auditors is for one year and it shall be extended, subject to the satisfactory performance and discretion of the competent authority in Kamala Nehru College. The performances of the internal audit team would be reviewed frequently and if not found satisfactory during the contract period, the competent authority of Kamala Nehru College shall terminate the engagement /contract, quoting the reasons.
- d) The details of Technical bid and financial bids are enclosed in Annexure A and Annexure B respectively.

#### 3. Other important points

- a) Bidders are requested to submit both the Technical and Financial Bid and all documents with the Application. The Technical Bid and Financial Bid are to be submitted in two separately sealed envelopes distinctly marked accordingly.
- b) The Successful bidders would be required to furnish Rs. 25000/- of the contract awarded value towards Performance Security Money in the form of Demand Draft favoring Principal Kamala Nehru College, payable at New Delhi.
- c) Bidders have to attach a Summary sheet and an Index of all the documents submitted.
