

6. The organizer is to ensure that due approval from Ministry of External Affairs and Ministry of Home Affairs are taken for the visit of any participant resource person from abroad and ICPR will not be answerable for non-compliance of any such norms.

The above documents are mandatory requirements to settle the account. Other important Terms and Conditions are:
