This is in reference to the Advertisement given by the College regarding tender dated 17.05.2023, Ref. No. KNC/2023/1887 and Corrigendum Ref. no. 1. Scope of work (Annexure-1)

2. Point no. 18 Overall Bid Evaluation Process :

- a) Selection of the Bidder for opening of Financial Bid shall be based on Quality and cost Based Selection (QCBS) with minimum 70 marks out of 100. (Sl. No.3 below under point no.19.2)
- b) The evaluation shall consist of following stages :

i) Stage I-Evaluation of Technical bid based on QCBS method (Note: The QCBS score will be intimated to all participating bidders after which the financial bid will be opened in the presence of bidders)

ii) Stage-Evaluation of Financial bid.

3. Point no.19 Stage-I Evaluation of Technical Bid for QCBS assessment

19.1 Technical bids for QCBS assessment will also be reviewed for compliance with the necessary Instructions, terms and conditions, scope of work, formats etc. as outlined in this tender

SCOPE OF WORK FOR Time Table Module

The Web based 'Time Table Module' should be designed and developed based on open-source technology and have the following features/ functionalities:

1. Admin Login
2. Add/Edit/View Rooms
3. Add/Edit/View Faculty
4. Add/Edit/View Papers
5. Add/Edit/View Groups (Name, Type (Core/Elective))
6. Provision to add timetable, on the basis of Faculty, Course or Room. In each view for a given slot, provision to be there for copy/move/add/edit/delete a slot
7. Download for Print the Timetable
8. View empty rooms for a given slot
9. Customized Reports
10. Link to the College Website for viewing Course Wise, Room Wise & Faculty Wise timetable

Technology Stack

1. HTML, CSS, JS, Angular JS, React JS
2. PHP, Java
